NOTICE OF 2024 OACD BOARD ELECTIONS

District Board Members and Management Staff:

We are now requesting nominations for OACD board positions. Please see the listing of positions below that are up for election. The term is for 3 years, serving until December, 2027.

Candidates may self-nominate by sending a statement of 150 words or less by 5:00 p.m. on **September 20** to OACD (andrea.kreiner@oacd.org) indicting why they want to serve and their qualifications in a brief bio of 150 words or less (see example at the end of this notice). Remember that both district board directors and management staff are both eligible to be elected. The bylaws require that management staff have their board send an email to OACD affirming the candidacy of their staff to assure that the district can support the necessary time commitment.

We will send out the list of candidates with their statements by **September 27** with a ballot. We are asking that each district complete the ballot and return it to OACD by **November 29**, allowing up to two board meetings for districts to vote based on their internal discussion. Each district can submit a ballot by mail or electronically representing the district's choices (one ballot per district). Director seats will be determined by the highest number of votes. We request that you send ballots back electronically and then confirmation of receipt of ballots will be provided. Ballots will be tallied and results available by **December 12**.

Following the election process, the new and existing board members will meet virtually at the OACD board meeting in **December** to elect officers and transact any business.

Positions:

- Northwest Oregon Region. The list of districts eligible for this position are: Benton, Clatsop, Columbia, Lincoln, Linn, Polk, Siuslaw, Tillamook, Upper Willamette, Yamhill.
- <u>Southern Oregon Region</u>. The list of districts eligible for that position are: Coos, Curry, Douglas, Ft. Rock Silver Lake, Illinois Valley, Jackson, Klamath, Lakeview, Two Rivers, Umpqua.

Don't forget that <u>dues must be paid</u> for a candidate to be nominated from a district and for districts to submit a ballot in the election. NRCS IS OFFERING CONSERVATION PLANNING PART TWO

Offered in partnership with the National Conservation Planning Partnership this July, August, and September. This course meets the requirement for conservation planning procedures core competency as a conservation planner for all states and U.S. territories. There is no registration fee, but all meal, travel and incidental costs are incumbent of the participant or participant's employer.

Grant Opportunity for Urban Forestry



The Oregon Department of Forestry (ODF) Urban & Community Forestry received \$26.6 million to stand up two subaward programs offering \$10

million explicitly devoted to the nine Federally Recognized Tribes of Oregon, and \$12.5 million available to all eligible entities in the State of Oregon. Both funding opportunities aim to promote community and urban forest investment and tree equity for overburdened and underserved communities. This initiative strives to support Tribal, rural, and urban communities by providing benefits beyond individual project or program investments.

o Tribal Program:

Proposals may be submitted on an ongoing basis through **June 30, 2026.** The funding range is \$10,000 - \$1,000,000 with no match required. The application template can be found here: PDF | WORD and the budget template can be found here. ODF has staff capacity and additional funding available to offer support with grant application, award, and administration processes or reporting. To seek support, see their Subaward Assistance Questionnaire.

o All Entities Program:

Proposals may be submitted from **July 1 to September 30, 2024.** The funding range is \$10,000 - \$750,000 with no match required. The application template can be found here: PDF | WORD and the budget template can be found here. ODF has staff capacity and additional funding available to offer support with grant application, award, and administration processes or reporting. To seek support, see their Subaward Assistance Questionnaire. Note that applications may be submitted by individual entities or coalitions of multiple entities.

Columbia River Fund now accepting applications

The <u>Columbia River Fund</u> is accepting grant applications and the grant deadline is July 16, 2024. This fund supports projects designed to improve, protect, and benefit clean water and aquatic habitat in the Columbia River Basin. Grants will be awarded to community oriented and grassroots groups or organizations with a strong track record of community-based water quality stewardship. This fund especially encourages projects that involve front-line, impacted communities and that are centered around principles of equity and environmental justice.

Wetland Reserve Enhancement Partnership

This year, NRCS will build on its wetland restoration efforts with up to \$50 million in the Wetland Reserve Enhancement Partnership (WREP) in fiscal year 2024, to support conservation partners with local projects that help protect, restore and enhance critical wetlands and mitigate climate change on agricultural lands.

Section 319 Nonpoint Source Implementation Grants Program

DEQ is now accepting project proposals for the 2024 grant cycle. DEQ invites nonpoint source project proposals that implement watershed based plan priorities or emphasize equity and environmental justice. Please refer to the request for proposals for more information.

Successful projects may commence in spring of 2025 after project agreements are signed.

DLCD Coastal Zone Management Habitat Protection & Restoration Grants

Local governments, cities and counties, other non-federal public entities, federally recognized Indian Tribal governments, institutions of higher education, and in some cases, non-profits can apply to fund habitat restoration, restoration planning and land acquisition. Restoration projects must be conducted on lands owned or controlled by a non-federal public entity and land acquisition projects must have final ownership held by a non-federal public entity. Non-federal public entities are eligible to submit grant applications with a budget of up to \$6 million for project costs. While **matching funds are not required**, cost sharing is an important element considered in the evaluation criteria. This funding aims to boost resilience through large-scale habitat restoration and conservation in coastal ecosystems, promoting coastal resilience in underserved and climate-vulnerable communities. Restoring and acquiring ecologically significant areas like wetlands, headlands, and natural shorelines will help reduce the impact of coastal hazards, including flooding and climate change, on property and infrastructure, while also providing economic benefits to coastal communities.

- DLCD requires all to schedule a 'Pre-application' Consultation meeting with our staff. You can schedule a Pre-Application Meeting any time prior to submitting your Letter of Intent to DLCD, but the meeting will be most useful to you early in the process. We would like to meet with you for an informal conversation to review basic information about your proposed project, and ensure you are proposing an eligible project that will meet NOAA's funding requirements. This is also an opportunity for potential applicants to ask OCMP/DLCD staff questions about the funding program and proposal development. Well Abandonment, Repair, and Replacement Fund grants

The Oregon Water Resources Department (OWRD) <u>Well Abandonment, Repair, and Replacement Fund</u> (<u>WARRF</u>) provides grants to qualifying homeowners to reimburse them for the cost to repair or replace and abandon a dry or severely declining well or a well that was damaged or destroyed by wildfire that is unable to supply water for household purposes. The well must have provided household water for individual households, or members of a federally recognized tribe in Oregon. Please see the <u>WARRF Website</u> and <u>WARRF</u> <u>Guidance for Homeowner's</u> document for additional information and application instructions.

- **Grant Awards:** Funding up to \$40,000 per grant will be awarded to eligible applicants who submit completed applications in the order received until all funds have been awarded.
- Total Funding Available: \$1 million

Oregon Agricultural Heritage Commission is recruiting for a Commission seat to represent natural resource interests

The Oregon Agricultural Heritage Commission is recruiting for a Commission seat to represent natural resource interests. Commissioners serve 4-year terms, are recommended by various boards, and are appointed by the OWEB). The term for the seat is October 2024 through January 2027; commissioners are eligible to serve two consecutive terms.

About the Oregon Agricultural Heritage Program:

The State Legislature established the Oregon Agricultural Heritage Program (OAHP) in 2017 to provide voluntary incentives to farmers and ranchers to support practices that maintain or enhance both agriculture and natural resources such as fish and wildlife on working lands.

Tide Gate & Tidal Wetland Monitoring: Guidance and Protocols for Estuary Practitioners Handbook

In 2018, a need for standardization of tide gate monitoring parameters and protocols was identified in the publication *Ecological Effects of Tide Gate Upgrade or Removal: A Literature Review and Knowledge Synthesis* (Souder *et al.*). In answer to this need, the *Tide Gate & Tidal Wetland Monitoring: Guidance and Protocols for Estuary Practitioners* handbook was published in 2024. The handbook comes through funding from OWEB in collaboration with the Coquille Watershed Association, the Nature Conservancy, and the Tillamook Estuaries Partnership and input from the Columbia River Estuary Study Taskforce, the Confederated Tribes of Siletz Indians, and Laura Brophy at the Institute for Applied Ecology.

Tide Gate & Tidal Wetland Monitoring Guidance & Protocols for Estuary Practitioners aims to establish a standard for recordkeeping and monitoring that unites the restoration community under a single, well-defined set of reporting standards, protocols, and procedures to monitor tide gate upgrade and replacement projects.

DEQ Rulemaking - Powder River Basin Bacteria TMDL and WQMP - Rules Adopted

The Environmental Quality Commission adopted rules that establish a Total Maximum Daily Load to address the impairments to water quality standards and beneficial uses in surface waters in the Powder River Basin. These impairments are caused by excess bacteria and will be addressed by identifying and quantifying sources of this pollutant. This rule also establishes a water quality management plan that includes pollutant management strategies, a list of parties responsible for developing management plans and implementing strategies, and a timeline to reduce pollutant loads and attain water quality standards. DEQ submitted the TMDL to EPA on May 30, 2024, for approval.
