#### Bringing Back "Fully Functional" Wildlife Tax Deferral Programs

- <u>Wildlife Habitat Conservation and Management Program</u> (WHCMP)
- <u>Riparian Lands Tax Incentive Program</u> (RLTIP).



## **Case Study Timeline**

- ✤ 2016: West Multnomah Board Member Raises Issue of the WHCMP Not Being Available
- 2017: Initial Discussions at OACD Lower Willamette Basin Team Meetings
- 2018: Collaborative Meeting of the Minds (Lower Willamette SWCDs, ODFW)
- ✤ 2018: Lower Willamette Basin Team Meeting to Form Consensus on Path Forward
- 2018: Hard Conversations with ODFW SWCDs Needed Firm Commitment from ODFW on Goal
- 2019 (July): Formal Intergovernmental Agreements Executed

- 2019 (November): Phase I (Getting the House in Order) Completed
- ✤ 2020: Six Month Time Out (COVID-19, Office Relocations, Strategic Planning, Disability, ....)
- 2020: Effort Resumed Wildlife Tax Deferral Programs Work Group Formed (SWCDs, Other Partners)
- 2020 (December): Four pronged approach: (1) Pilot, (2) Legislative, (3) Messaging, (4) Fundraising

January through July – Monthly Meetings of the Work Group.

- Legislative Strategy Developed and Implemented (Details Forthcoming)
- ✤ July through November Meetings with ODFW North Willamette Watershed District Develop Pilot
- July through August Broaden Awareness (ODFW Conservation Open House, Oak Leaders Group)
- November through February 2022 Work Group Preparation for Spring Informational Hearing

## **Confirm Policy Action Need**

<u>Policy Action</u> – Bring back fully functional wildlife tax deferral programs (specific emphasis on WHCMP)

- Need identified by West Multnomah SWCD Board Member
- Brought to the attention of neighboring SWCDs
- Recognized and shared by other SWCDs

- Vetted with Oregon Department of Fish and Wildlife
- Consensus it was a shared priority to pursue taking action.



## Form a Coalition – Initial Collaboration

#### Lower Willamette Basin SWCD Wildlife Tax Deferral Program Team Formed

- Willing to Lead Effort West Multnomah, Clackamas SWCDs
- Willing to Support Effort Polk, Tualatin SWCDs
- Willing to Join Effort if Effort Expanded East Multnomah SWCD
- Willing to Monitor Effort Marion, Yamhill SWCDs



## **Identify Influencers – Decision-Makers**

## <u>Decision Maker</u> – Oregon Department of Fish and Wildlife (ODFW) Headquarters Staff

#### Influencers

- ODFW North Willamette Watershed District (Internal)
- Oregon Legislature (Primary)
- Secondary Influencers (Entities that Influence the Primary Influencer)
  - Oregon Conservation and Recreation Fund Advisory Committee
  - □ Willamette Partnership
  - Pacific Birds Habitat Joint Venture
- Tertiary Influencers Those Who Influence the Secondary





#### <u>Lower Willamette Basin SWCD</u> <u>Wildlife Tax Deferral Program Team</u>

- Held Meetings with Decision Maker and Internal Influencer
- Invited and Received Participation by Interested Board Members
- First Things First A barrier for moving for ODFW's ability to move forward was "getting their house in order".
- Decision to Collaborate
  - □ SWCDs provide resources to ODFW so ODFW can "get things in order".
  - ODFW makes commitment to supporting outcome fully functional wildlife tax deferral programs are available statewide.





#### <u>Lower Willamette Basin SWCD</u> <u>Wildlife Tax Deferral Program Team</u>

- Plan Mapped Out all the Steps Needed to Achieve End in Mind (Fully Functional Wildlife Tax Deferral Programs)
  - □ Phase 1 Know What You Got Monitoring and Compliance
  - □ Phase 2 Implement WHCMP And RLTIP Monitoring Schedule
  - □ Phase 3 Accept New WHMCP and RLTIP Applications
  - Phase 4 -- Secure Fully Functional Programs



## **Secure Commitment to the Plan**

#### Inked Formal Agreements

- 1) External Intergovernmental Agreement (IGA) -- Working Towards Fully Functional Habitat Incentive Programs for Private Lands in Partnership with Soil and Water Conservation Districts between Lower Willamette Basin SWCDs (as a coalition) and ODFW
- 2) Internal Intergovernmental Agreement (IGA) Lower Willamette Basin Soil and Water Conservation District Funding for Fully Functional Oregon Department of Fish and Wildlife Tax Incentive Programs between individual Lower Willamette Basin SWCDs



**Develop Relationships Expand Collaboration** 

- Willamette Partnership Joined the Coalition
  - □ Brought in Pacific Birds Joint Habitat Venture
  - Connected the Effort to Oak and Prairie Leaders Group
- OACD Advocacy Committee Prioritized the Need for Policy Action
  - Executive Director Became a Critical Resource
  - Legislative Tracking by the Advocacy Committee
- Jackson SWCD Joined and Expanded the Scope of the Coalition



## **2021 Legislative Strategy**

- February Briefed OACD Advocacy Committee; Solicited Support, Became Member
- April Meeting with Representative Jeff Reardon about ODFW Budget and Link to Tax Programs
- May 3rd OACD Testimony on ODFW Budget, Ways and Means Subcommittee on Natural Resources
- May 19th Meeting w/ Senator Kathleen Taylor's Legislative Aide Need for Field Positions
- ✤ June Legislatively Adopted Budget Includes Habitat Division and 7 New Field Biologist Positions
- ✤ July Meeting with Rep Reardon Request for Support for Fall 2021 Informational Hearing
- ✤ July Request for Informational Hearing to Rep Zach Hudson (Chair, House Ag & Natural Resources)
- Sept Request Handed Off to Rep Pam Marsh (Chair, House Environment & Natural Resources)
- Sept Meeting with Rep Marsh Verbal Commitment to Informational Hearing (Spring Session)
- January 2022 Check In with Rep Marsh Get Spring Informational Hearing Scheduled

#### <u>First PIVOT – The Need for An Informational Hearing</u>

- Address Misinformation about the Need for Wildlife Tax Deferral Programs
- Adopted Oak Woodlands as the Poster Child for the Need for WHCMP
  - Oak Woodlands Priority "Strategy" Habitat in Oregon Conservation Strategy
  - □ Oak Woodland Conservation Statewide in Scope (5 Regional Efforts)
  - Oak Woodland Conservation Opportunity Primarily on Private Lands
  - Oak Woodland Conservation Does not fit Agriculture and Forestry Tax Deferrals
  - Oak Woodland Conservation Costly to Landowners; Reduced Revenue Opportunity
  - □ Wildlife Tax Deferral Removes Key Barrier to Private Landowners Taking Action
- Show how Leveraging SWCD Capacity to Lower State Program Costs

## Affirm/Modify the Plan

#### <u>Second PIVOT – Legislative Strategy for 2021 Session</u>

- Phase 2 Monitoring and Compliance Blocked by Lack of Field Capacity
- Budget Outlook Favorable to Discussing ODFW's Field Capacity
  - □ Governor's Budget Proposed Recreating ODFW's Non-Game Habitat Division
  - □ ODFW's Budget Request Identified Field Positions Needed in Habitat Division
  - □ Legislative Support for the Oregon Conservation and Recreation Fund
  - □ OACD Advocated for Adding Back the Habitat Division Field Positions
- Supporting ODFW's Budget for Habitat Division Would Further Our Cause
  - □ Increased Field Biologist Capacity Helps with Offering WHCMP and RLTIP
  - Allowed for Behind the Scene Discussions on Importance of the Wildlife Tax Deferral Programs; Set the Stage for Asking for Informational Hearing



## Affirm/Modify the Plan

#### Where We Got Lucky

- Turned Out the State Legislature Had Plenty of Money to Work With
  - □ Federal Initiatives Recovering America's Wildlife Act Showed Promise
  - □ Loss of Revenue from Pandemic was Lower than Forecasted

- □ Federal Stimulus Money Added Free Up State \$\$\$ that Otherwise Were Unavailable
- Clackamas SWCD, Jackson SWCD Constituents of Key Legislators On Key Committee's (Representative Jeff Reardon, Representative Pam Marsh)





#### **Collaboration**

- We Worked to Help ODFW Succeed in 2021 Session with respect to the Budget for Field Positions within the Habitat Division
- ODFW North Willamette Watershed District Helped Us Succeed

- □ Agreed to Enter the WHCMP Pilot Project (Centered on Oak Woodlands)
- Supportive of Initiating Legislative Discussion through the Informational Hearing
